Invoice terms are payment within seven (7) days of issue. 1.2 **Suite or Table Allocation:** WRI reserves the right to consider and process bookings on a 'first in, first served' basis. Suites or table preference will be considered; however, the final allocation is at the sole discretion of WRI management. Once booking requests are confirmed and 100% of the booking fee processed, the suite/table allocated, the Suite or Table number details will be forwarded along with entry tickets (eTickets) for the event. 1.3 **Cancellation by Corporate Booking Holder:** Corporate Booking Holders who cancel their table or suite booking within 14 consecutive days prior to the event date will not be entitled to a refund.
