# Corporate Suite Bookings

## Terms & Conditions

In these Terms & Conditions, Willowbank Raceway Inc (WRI) refers to the organiser, and the company or individual making the booking is the Corporate Booking Holder.

### **1. Booking Fees**

#### **1.1 Confirmed Bookings & Payment**

- Bookings are confirmed in writing by WRI.
- A deposit must be processed via your nominated payment method to secure your booking.
- Full payment invoices are due within 7 days of issue.

#### **1.2 Suite or Table Allocation**

- Bookings are processed on a first-in, first-served basis.
- Preferences are considered, but final allocation is at WRI management's discretion.
- Once full payment is received, your Suite/Table number and eTickets will be provided.

### **2. Cancellation Policy**

#### **2.1 By the Corporate Booking Holder**

- Cancellation within 14 days of the event: no refund.
- Cancellation 15-30 days before the event: refund less \$50 admin fee.
- All cancellations must be submitted in writing.

#### **2.2 By WRI**

- WRI may cancel an event if safety risks exist.
- If cancelled before the advertised opening, a full refund applies.
- If cancelled after the event has commenced, no refund is provided.
- By booking, you accept WRI's right to cancel under these terms.

### **3. Corporate Booking Rules**

- Non-attendance without notice: No refund.
- Resale/transfer: Bookings may not be resold or transferred.
- Amendments: WRI may amend these conditions; every effort will be made to notify booking holders.
- Smoking: Smoking is only permitted in designated areas.
- Behaviour & Damage: Disorderly behaviour or property damage is prohibited; costs incurred are the responsibility of the booking holder.
- Vehicle Access: All directions from WRI management must be followed.

### **4. Privacy & Compliance**

- WRI collects information to manage bookings and communicate with Corporate Booking Holders.
- Breaches of these conditions may result in expulsion from the facility.
- WRI's decisions on disputes are final.
- All fees are inclusive of GST, unless stated otherwise.
